1. Draft Discussion Paper

Action: Fiona was asked to carry the contents of the Discussion paper forward into the DCMB Strategic Planning process that Greg Sarre (DCMB) is leading.

2. Current Projects

Allana provided a summary of the progress of current small projects and community feedback on priorities.

The meeting discussed the Landcare project to develop a Butterfly garden / children's nature park with special note of the enthusiastic participation of the local community

Allana said that the Bus Shelter project needed more consideration with reports from the community that students are not picked up from one site but rather a number of different points.

Allana spoke about potential funding sources (like grants) and was waiting on more information from DCMB on this subject.

Fiona provided a list of other possible projects for discussion and possible inclusion on the Master Planning small projects list (Fiona to attach list).

3. Meeting with Minister

The meeting noted that Hillgrove was planning to invite the Resources Minister to the Kanmantoo Copper Mine for a site visit and tour.

Action: The Chair was asked to work with Steve to see if it is possible to include a meeting with the KCCCC on the program for the future site visit by the Minister.
