## 3. Master Plan

#### 3.1 Master Plan Review

- Gallery members were provided an overview of the intent of KCCCC to community members for additional context, including the part of local council representation.
- 2<sup>nd</sup> draft of the KCCCC summary brochure presented and discussed. Next steps are to finalise wording and Gary and Nikki Fletcher will work on the design of the pamphlet.
- GN has assessed the Kanmantoo underground operation against the Master Plan rubric. Preliminary score was 74/100 comprising the below:
  - Environment (13/15), Heritage (12/18), arts and culture (13/24), Economic Development (18/21), Pillars (5/5), Inclusion (3/5), Balance (5/5), Governance (5/5) and Template (0/5).
- GN will send preliminary results rubric results to KCCCC.
- Question raised about how the rubric's weighting was designed. It was confirmed by the committee that it is currently under review, reassess the validity.
- It was reported that Airlie Keen has put forward a motion for the July Murray Bridge Council meeting for the K4C Masterplan to be formally considered during our Strategic Planning work. In terms of a deputation or similar, it is suggested a meeting be held with the community engagement team, during the consultation phase which is likely to occur during Jan to Mar 2024.

# 4. Kanmantoo Copper Mine

Glenn Norris provided the following updates.

### 4.1 Compliance / Emission /Rehabilitation

- No new compliance issues during the last quarter.
- Continue to monitor dust, surface water, ground water, soil, flora, fauna, landowners bores.
- Revegetated areas being maintained on-site and off-site including seed harvesting and processing, spot spraying, hand weeding and slashing high quality revegetated areas, pest management.
- Blasting recommenced on 24 May 2023 with all blasts well under the compliance limit (see chart).
  - Vibration limits as recommended in AS2187.2 are used and are based on minimising human discomfort and are well below the levels likely to produce structural damage.
  - The following blast vibration and overpressure limits have been set.
    - PPV Residential sites: 5 mm/s for 95% blasts per year. 10 mm/s maximum.
      DPV Generation sites (Neutrophy 25 mm/s for perimeter)
    - PPV Commercial sites (Neutrog): 25 mm/s maximum.
  - $\circ~$   $\sim$  50 blasts have been undertaken since 24 May with the highest vibration reading 0.17 mm/s (see chart)



## 4.2 Kanmantoo Underground

Glenn Norris gave a presentation on the progress of the Kanmantoo Underground project. Updates from last meeting.

- Underground development mining has commenced!
- Glenn ran through the mining process from development drill and blast, haulage, installing ground support, scanning of rock faces, TSL application and broad activities for the next 6 months.
- Other areas on the site that have the potential to extend the mine life.
- Upcoming employment opportunities discussed including the personnel ramp up profile for the operation.

- Expected to be a steady ramp-up of people employed for the operation from midyear.
- $\circ~$  Around 180 full time employees planned at peak production along with specialist contractors.
- Hillgrove has a local hire policy meaning candidates living in the local area are preferentially employed when they have the necessary skill sets.
- Nikki Fletcher Manager HR, Safety and Environment to present employment opportunities at next KCCCC meeting.
