## 4. Kanmantoo Copper Mine

Glenn Norris provided the following updates.

## 4.1 Compliance / Emission /Rehabilitation

- No new compliance issues during the last quarter. Still monitoring groundwater bore on site with elevated metals. Metals not seen spreading to other bores on or off site
- Continue to monitor dust, surface water, ground water, soil, flora, fauna, landowners bores.
- Hillgrove Sustainability report completed and released to ASX along with Annual Report.
- Quarterly noise monitoring conducted during blast times.
- Revegetated areas being maintained on-site and off-site including seed harvesting and processing, spot spraying, hand weeding and slashing high quality revegetated areas, pest management.
- Since blasting has commenced (May 2023) there have been two calls from the same person within Kanmantoo regarding vibration- one was later in the night than we normally blast. Gary enquired if it was along a fault line which it was. All blasts conducted have been well below allowable limits stipulated in mining lease conditions.

## 4.2 Kanmantoo Underground

Glenn Norris gave a presentation on the progress of the Kanmantoo Underground project. Updates Since last meeting.

- Development mining (tunnels) approximately 3km advance total. Increased to 500 m per month now that a second jumbo is on site and stepping up from there.
- Images of workings shown progress from November 2023 to March 2024 including location of first stope.
- Updates since November meeting:
  - Installation of grid power to underground workings
  - Copper concentrate containers arrived at Port Adelaide. These will be used to transport and store product at the Port. Product is emptied out of containers into the hull of ship when exported.
  - Crushing plant commissioned.
  - First copper concentrate produced.
  - First copper concentrate sale occurred.
- Various photographs of the mining and processing operations were shown.
- A promotional video about the Kanmantoo Copper Mine and Hillgrove Resources was shown. This is available on the Hillgrove Resources website and on Hillgrove's "You Tube Channel".
- Question about Emergency Response and response to a bushfire through revegetated areas.

# 5. Other Business

## 5.1 Native Vegetation Grant – Kanmantoo Grassy Woodland Project Update

- Harry Seager provided an update on the Kanmantoo Grassy Woodland Project which has commenced following the awarding of a grant from the Native Vegetation Council Fund (NVC). This was presented on behalf of "Second Nature Conservancy" (formerly GWLAP) as Ross Oke was an apology for the meeting. The presentation was put together by Ben Simon from Second Nature Conservancy.
- Project aims:

- Develop/improve 160 Ha of Drooping she-oak +/- Peppermint box grassy woodland revegetation over 8 years.
- Improve 7.5 Ha of River red-gum on the Dawesley Creek.
- 68,000 seedlings to be planted overall.
- Approx. 10,000 hand direct seeded spots to be undertaken.
- At least 2,000 threatened flora species established.
- Progress:
  - $\circ$   $\;$  Initial and follow-up site visits with landowners and contractors.
  - Key attributes and exclusions mapped.
  - Draft heritage agreement boundaries submitted to DEW.
  - Baseline bird monitoring undertaken with 50 native bird species recorded to date including nationally vulnerable Diamond Firetail and rare Crested Shrike-tit.
  - 22 individual quadrants set-up using Bushland Condition Monitoring (BCM) to capture current vegetation condition.
  - Rabit and weed control commenced.
- Other comments:
  - With this project and previous projects, there will be 700-800 hectares of "increasingly high-quality vegetation" in the Kanmantoo/Callington area that wasn't there 20-25 years ago; providing habitat refuge for Woodland Birds of the Mt Lofty Ranges.
  - This work provides important benefits for the community and Karlene praised the substantial effort by all involved – particularly Ed, Harry, Ross, Hillgrove to lobby the NVC and be awarded the grant.
  - Well done to the KCCCC for not taking "no" for an answer and continuing to pursue funds. This has created a new paradigm for the way the NVC assesses projects.

#### 5.2 Other

- The impact of Neutrog dust/odour was raised on a number of occasions during the meeting. It was re-iterated by the Chair that the KCCCC isn't taking a position or advocating for the community over Neutrog issues, but if KCCCC did receive a letter, Glenn and Karlene would formulate a response together to forward that to the relevant persons.
- Mel on behalf of the Callington Primary School acknowledged Hillgrove's donation to assist with fundraising for the Toy Run. Even though it was cancelled, Hillgrove will honour commitment for this upcoming year.
