# 3. Master Plan

#### 3.1 Master Plan Review

- Gallery members were provided an overview of the intent of KCCCC to community members for additional context, including the part of local council representation.
- Final version of the KCCCC summary brochure including artwork and layout presented and discussed. Copies provided to the gallery.
- Final versions will be sent to the printer and distributed to the community.

# 4. Kanmantoo Copper Mine

Glenn Norris provided the following updates.

### 4.1 Compliance / Emission /Rehabilitation

- No new compliance issues during the last quarter.
- Continue to monitor dust, surface water, ground water, soil, flora, fauna, landowners bores. Glenn provided a brief summary of what this involves.
- Revegetated areas being maintained on-site and off-site including seed harvesting and processing, spot spraying, hand weeding and slashing high quality revegetated areas, pest management.
- 1000 kg of native grass seed harvested and in inventory. Some of this has been offered up for the NVC Callington project.
- Glenn explained areas of rehabilitation on the site map.
- Continuous dust monitoring to recommence in October. Moving from deposition gauge method as operations recommence.
- Noise monitoring to recommence in September.
- Annual Monitoring and Rehabilitation Compliance Report being compiled.

## 4.2 Kanmantoo Underground

Glenn Norris gave a presentation on the progress of the Kanmantoo Underground project. Updates Since last meeting.

- Underground development mining has continued.
- Development mining (tunnels) approximately 700m advance total.
- Overview of the mining process and current activities (development, bogging, haulage, diamond drilling, raiseboring).
- The next quarter will see production drilling, stope ore production, egress ladderway installation, processing plant testing and refurbishment.
- ASX releases for growth opportunities on the mining lease summarised (x 2)
- Upcoming employment opportunities discussed (see other business)

• Glenn to update site arial photograph in his presentation to show progress.

# 5. Other Business

#### 5.1 Hillgrove Employment Opportunities

- Nikki Fletcher (Hillgrove Manager HR, Safety & Environment) gave a presentation on upcoming employment activities at the mine. It has primarily been experienced mining personnel recruited to date but there will be opportunities for inexperienced personnel in the coming months. These roles will include truck drivers, nippers, field technicians, processing operators, mechanical and electrical trades.
- Nikki spent time with those interested to learn more about the roles that will be available.
- Other roles will be offered through contractors operating at the site and these will be advertised separately but Hillgrove will pass on resumes of locals who may be suitable for these other roles.
- Hillgrove may look at putting on apprentices in the future targeting local candidates.

#### 5.2 Hanson Quarry Update

- Steve Seal from Hanson Quarries was invited to provide an update to the community on the mining lease approval process for the Kanmantoo Quarry. He gave a presentation to the KCCCC and the gallery on the current state of progress.
- The DEM is currently completing its assessment then will prepare an assessment report and recommendation.
- If this ML is granted, then Hanson must secure approval for a Program for Environmental Protection and Rehabilitation (PEPR). This involves:
  - consultation with stakeholders
  - o preparation of an engagement plan
  - PEPR submission to the DEM
  - DEM assessment of the submission
  - Completion of obligations for approval
  - Approval to start
- The lease has 30 conditions that must be met, and Steve communicated that Hanson are happy to provide formal or informal updates to all interested stakeholders.
- The quarry operations can be viewed at any time by contacting Steve or Larry Neale (Quarry Manager). Steves e-mail address is <a href="mailto:steve.seal@hanson.com.au">steve.seal@hanson.com.au</a>
- It was noted that there was considerable concern from the community around the consultation process for the quarry expansion and whether there would be the opportunity for further concerns to be voiced. One particular concern was associated with increased truck movements through the townships of Callington and Kanmantoo.

## 5.3 Draft Kanmantoo Township

- Steven Conn, Senior Strategic Planner for Mount Barker District Council provided an update on the Draft Kanmantoo Township Plan.
- Township plan represents both the community vision and council vision for the future of the township.
- Council is preparing a DRAFT township plan prior to broader consultation.
- There will be a drop-in session at Hutton Reserve, Kanmantoo scheduled at a later date to facilitate further consultation.
- There will be further opportunity for the community to provide feedback through YourSAy, council website etc.

### 5.4 Native Vegetation Council Project

• \$1.35M received from the Native Vegetation Council Fund for the Callington Native Vegetation project. Well done to those involved!

### 5.5 Callington Oval Lighting Upgrade

• The Callington Recreational Park is seeking assistance to fund oval lighting upgrades. Hillgrove committed to donating \$10k to this project.
